**DIRECTIONS:**

- **APPLY TO SOIL.**
- **RATE: 1-3 LBS PER ACRE (PER SEASON).**
- **INJECT THROUGH CONTROLLED IRRIGATION SYSTEM, OR**
- **SPRAY ON SOIL WITH 10-20 GALLONS OF WATER PER ACRE AND THEN WATER INTO THE ROOT ZONE OR WAIT FOR RAINFALL.**
