PRODUCT DESCRIPTION:

A super formulated Zinc

GUARANTEED ANALYSIS:

Zinc Carbonate 8%

DERIVED FROM:

Zinc Carbonate ZnCO₃

DIRECTIONS:

- Transplanting: For field crops, use 1-3 pounds per 100 gallons of water. Use 200 gallons per acre. For smaller quantities, use 1 tablespoon per gallon.
- Apples, Plums, Cherries, Peaches, Pears, Walnuts and Pecans: For early season sprays use 5-10 pounds per acre with concentrate sprayer to improve tree vigor and fruit set. Use only 2 pounds per 100 gallons as a dilute spray.
- Strawberries: Apply 1-3 pounds per acre when buds appear. Repeat weekly.
- Field Row Crops: Soybeans, Field Corn, Beets and Sweet Potatoes: Apply 1-3 pounds per acre. Use 2-5 applications per season.
- Carrots, Parsley and Asparagus: Foliar applications should be made with 1-3 pounds per acre as needed to maintain growth.
- Cole Crops, Spinach, Lettuce, Celery, Tomatoes, Peppers and Cucurbits: Apply as a starter solution when planting in field as described under Transplanting instructions. After several weeks growth use 1-3 pounds per acre every 7-10 days.
- Beans, Peas, Onions and Sweet Corn: After several weeks of growth use 1-3 pounds per acre every 7-10 days.
- Grain Crops: Wheat, Oats, Rye and Alfalfa: Use 1-3 pounds per acre. Make 2 applications, first application at tillering and one more application at heading stage.

- Grapes and Berries: Use 1-3 pounds per acre early in season to stimulate cane or vine growth. Do not use this product in late growing stages or 2 months prior to ripening.

General Foliar Application for Greenhouse Crops:

- Use at the rate of 1-3 pounds per 100 gallons depending on type of plant and growth stage. Do not apply to drought stressed plants.
- 1 TBSP/gal = 3 lbs/100 gallons.

CAUTION:

Prior to combining Zierra Zinc with other materials, consult with a qualified representative. Always perform a jar test to make sure all ingredients are compatible.

GENERAL DIRECTIONS:

Store the product in a cool, dark and dry place.
